

**Directions:** Travel on the Long Island Expressway, Northern State Parkway or Southern State Parkway to Meadowbrook State Parkway to exit M4 (Hempstead Turnpike, Route 24). Proceed west on Hempstead Turnpike to the Hofstra University campus (approximately 1.5 miles). Turn right at light before second pedestrian bridge, entering North Campus. At the second stop sign, bear left and park. Walk into the Mack Student Center (building with clock tower). Follow signs to the Multipurpose Room.
